The Florida Bar Approves Legal Outsourcing

Ius Juris submissions to *The Florida Bar* well received and agreed upon

Orlando, Florida, U. S. A., July 28, 2008: ***The Florida Bar*** agreed that Florida attorneys are not prohibited from engaging the services of an overseas provider, as long as the lawyers adequately address the ethical obligations they have. The Opinion of the Bar's Professional Ethics Committee was approved by the Board of Governors of ***The Florida Bar*** during their meeting at Clearwater, Florida on July 25, 2008. ***Ius Juris, LLC***, a leading LPO headquartered in Orlando, Florida, with its offshore offices in Kolkata, India, was the only LPO to make formal written and oral submissions on this, and it did so to both the full Professional Ethics Committee as well as the Board Review Committee of ***The Florida Bar***.

Ius Juris had made submissions addressing the relevant ethical obligations Florida attorneys have and need to comply with. These obligations relate to

- a. The need to adequately supervise the non-lawyer;
- b. The need to act competently and exercise independent judgment;
- c. The client's confidences and secrets need to be preserved;
- d. Avoid conflicts of interest;
- e. Bill for the outsourcing work appropriately; and
- f. When and where necessary, obtain advance client consent to outsourcing.

In approving legal outsourcing, ***The Florida Bar*** joins the findings, opinions and rulings of the ***Los Angeles County Bar Association*** (June 2006), the ***Bar of the City of New York*** (August 2006) and the ***San Diego County Bar Association*** (January 2007). Kiran Chhaganlal, C. E.
